Important Notes:

- For BTech (from batch 2016 onwards):-
 - The most economically backward students (whose family income is less than Rs. 1 lakh per annum) shall get full remission of the tuition fee.
 - The other economically backward students (whose family income is between Rs. 1 lakh to Rs. 5 lakh per annum) shall get full remission of 2/3rd of the tuition fee.
- Student belonging to SC, ST and PwD categories are exempted from payment of tuition fee of the respective programme.
- Dining charges to be paid as per actual.
- *For a PhD student residing in the Family Accommodation, rent will be Rs.12,000/- per semester.
- Students admitted under Institute Staff (IS) or Defense Force (DF) category, are exempted from payment of followings:
 - Group Insurance Premium per annum (per semester for PhD students) and Medical Fee, if they are not availing medical facilities of the Institute.
 - Security Deposit for dining (Rs.2,000/-) and Dining charges, if they are not availing dining facility of the Institute.
 - Security Deposit for Hall of Residence (Rs.2,000/-) and Accommodation Charges, if they are not availing Hall of Residence facility of the Institute.
