### FOR MERIT-CUM MEANS SCHOLARSHIP (MCM), REMISSION OF TUITION FEE AND INTEREST SUBVENTION ON VIDYALAXMI LOAN SCHEME

Online applications in the prescribed format along with a latest Income Certificate from SDO/ Tehsildar/ BDO/ MRO/ Anchal Officer/ Chairman /Executive Officer of Municipal Corporation or Income Tax Return for Assessment Year 2018-19 / Latest Salary Certificate issued by Government organization in original / are invited for **MCM** from all BTech and MSc students for **Fresh** and **Renewal**. Applications are also invited for **remission of tuition fee** from BTech **Batches 2016, 2017 and 2018** students only. Eligibility criteria and other details for the award of **MCM, Remission of tuition fee** and **Interest subvention** on Vidyalaxmi Loan Scheme for the Academic Year 2018-19 is mentioned below:-

(i) The existing awardees are required to apply a fresh for renewal with all required documents. (ii) The student must have secured minimum <b>CPI of 6.0</b> at the time of submission of application and <b>should not have any courses in which he /she has not earned credits.</b> (iii) The income should not be more than Rs. 6,00,000/- per annum for such scholarship.  If a student fails to submit Income Certificate or proof of family income for less than Rs. 6,00,000/- his/her scholarship shall be withheld and can be transferred to other eligible student who fulfills the criteria.	<b>a) For Gen &amp; Gen-PWD OBC-NC &amp; OBC-NC, PWD Category:</b> Institute Merit-cum-Means Scholarship of Rs. 1000/- per month with benefit of exemption Tuition fee. <b>For SC &amp; SC-PWD, ST &amp; ST-PWD Category:</b> Facilities of Free Dining (only basic menu), a Pocket Allowance of Rs. 250/- per month and Hall of Residence Seat Rent.


<b>Remission of Tuition Fee</b>	Only for BTech 2016 Onwards (i.e. Batches 2016, 2017 and 2018)	<b><u>For Gen and OBC Category:</u></b> For the students whose family income is less than <b>Rs. 1 lakh</b> per annum.	<b><u>For Gen, OBC Category:</u></b> They shall get Full remission of the tuition fee. i.e Rs 1 lakh.
		<b><u>For Gen and OBC Category:</u></b> For the students whose family income is between <b>Rs. 1 lakh to Rs. 5 lakh</b> per annum.	They shall get remission 2/3 <sup>rd</sup> of the tuition fee. i.e. Rs 66,667/-
		<b>Note:</b> No refund will be applicable for SC, ST & PWD students as they are already exempted from paying tuition fee.	
<b>Interest subvention</b>		c) All students whose house hold income does not exceed <b>Rs 9 lakh</b> shall be eligible for interest free loan under the <b>Vidyalaxmi scheme</b> for the total portion of the tuition fee payable.  d) <b><u>Criteria for renewal of availing interest subvention:</u></b> Student should secure a minimum CPI of 5.00 at the end of each semester AND should not have earned a non-credit grade in any registered course throughout the academic programme. If any student fails to fulfill these criteria at the end of any semester then he / she will discontinued from benefits of this scheme.	They shall have access to interest free loan under the <b>Vidyalaxmi scheme</b> for the total portion of the tuition fee payable.

### **Mode of Applying:**

Online applications need to be filled through AROL on <http://academic.iiti.ac.in/index1.html>. Upload latest income certificate/ Income Proof as mentioned above and submit print out of the online submitted application along with requisite enclosures to Academic Office latest by **August 27, 2018 (17:30 hrs.)**. After deadline no any further extension / communication will be considered.

### **NOTE:**

1. *Student who will get above scholarship can't avail any other scholarship from any Government, Semi-Government or private sources.*
2. *Decision of the Institute in this regard will be final and binding.*
