### FOR MCM SCHOLARSHIP & REMISSION OF TUITION FEE

Online applications in the prescribed form along with a latest Income Certificate from Tehsildar/SDO / BDO/MRO/Anchal Officer/Chairman /Executive Officer of Municipal Corporation or Income Tax Return / Certificate issued by Govt. organization in original / are invited for MCM from all B.Tech and M.Sc students for Fresh and Renewal. Applications for remission of tuition fee is from New B.Tech i.e. batch 2016 only. Eligibility criteria and other details for the award of the MCM, Remission of tuition fee and Interest subvention for the AY 2016-17 is mentioned below:-

**Online** applications needs to be filled and print out of the filled application along with requisite enclosures shall be submitted in Academic Office latest by **September 16, 2016**. Incomplete online application and hard copy of the same, submitted after the last date will not be considered.
