7. Students converted into dual degree programs of B.Tech. to M. Tech. or M.Sc./M. Tech./M.S. (Research) to Ph.D. programs will be required to pay the applicable fee of the converted program with effect from the date of the joining of the new program.

8. Students who converted into dual degree programs B.Tech. to M.Tech. or from M.Sc./M.Tech./M.S. (Research) to Ph.D., need to pay the difference in the security deposit for the new program.
