Sub: Remission of tuition fee, Interest subvention on vidyalaxmi loan scheme and Merit-Cum Means scholarship (MCM) for AY 2022-23

Online applications are invited for **Remission of tuition fee/ Interest subvention** from the students of B.Tech. **2019, 2020 and 2021 batches** and **MCM Scholarship** from the students of B.Tech. **2019 batches only** in the prescribed format along with the latest Income Certificate from Tehsildar/ SDO/ BDO/ MRO/ Anchal Officer/ Chairman /Executive Officer of Municipal Corporation or Income Tax Return for Assessment Year 2022-23 / Latest Salary Certificate issued by Government organization.

Eligibility criteria and other details for the **Remission of tuition fee, Interest subvention** on Vidyalaxmi Loan Scheme and scholarship of **MCM** for the Academic Year 2022-23 are as mentioned below: -

Criteria for Remission of Tuition Fee for B.Tech. (2019, 2020 and 2021 batches only)	
Eligibility as per parental income group per annum	Benefits under the remission of the tuition fee
(a) For GEN, OBC-NC and EWS Categories: (i) Less than Rs. 1,00,000/-	Full amount of the tuition fee.
(ii) Between Rs. 1,00,000/- to Rs. 5,00,000.	2/3 rd of the tuition fee.
Criteria for Interest Subvention on Vidyalaxmi Loan Scheme for B.Tech. (2019, 2020 and 2021 batches only)	
Eligibility as per parental income group per annum	Benefits under the Interest Subvention on Vidyalaxmi Loan Scheme
a) All students whose household income does not exceed Rs 9 lakh shall be eligible for interest free loan under the Vidyalaxmi scheme for the total portion of the tuition fee payable. b) Criteria for renewal of availing interest subvention: (i) Student should secure a minimum CPI of 5.00 at the end of each semester. (ii) should not have earned a non-credit grade in any registered course throughout the academic programme. If any student fails to fulfill these criteria at the end of any semester then he / she will be discontinued from benefits of this scheme.	Interest free loan under the Vidyalaxmi scheme for the total portion of the tuition fee payable.

Criteria for Merit-cum-Means Scholarship (MCM) for B.Tech. (2019 batch only)

<p>(ii) Between Rs. 1,00,000/- to Rs. 5,00,000/-</p> <p>Remarks: - Maximum of Top 5% students of above categories and student must have secured minimum CPI of 7.5 (for B.Tech.) at the end of every semester and should not have any courses in which he /she has not earned credits.</p>	<p>Full remission of tuition fee</p> <p>(1/3rd of tuition fee. i.e. Rs. 33,333/- in addition to remission of 2/3rd of the tuition fee. i.e. Rs 66,667/-)</p>

Mandatory self-attested documents are required while filling online application for the Above.

- (i) Parental Income Certificate (issued by competent authority)
- (ii) Caste Certificate, if applicable (issued by competent authority)
- (iii) PwD Certificate, if applicable (issued by competent authority)
- (iv) Bank Passbook (Photocopy for account details).

Note:

- Duly signed application form along with all relevant documents in a **single PDF file** need to be uploaded on AROL (Name of file must be your Roll No. only). If any student fails to upload the above documents on AROL, their application will not be considered.
- The last date for submitting the application is **June 30, 2022** and after the due date, no application/communication will be considered.
- A Student who will get above scholarship cannot avail any other scholarship from any Government, Semi-Government, or private sources.
- Decision of the Institute in this regard will be final and binding.
