Sub: Remission of tuition fee, Interest subvention on vidyalaxmi loan scheme for AY 2024-25.

Online applications are invited for remission of tuition fee/ interest subvention from the students of B.Tech. 2021, 2022, and 2023 batches in the prescribed format along with the latest Income Certificate from Tehsildar/ SDO/ BDO/ MRO/ Anchal Officer/ Chairman /Executive Officer of Municipal Corporation or Income Tax Return for Assessment Year 2024-25 / Latest Salary Certificate issued by Government organization.

Eligibility criteria and other details for the Remission of tuition fee, Interest subvention on Vidyalaxmi Loan Scheme for the Academic Year 2024-25 are as mentioned below: -

Criteria for Remission of Tuition Fee for B.Tech. (2021, 2022 and 2023 batches only)	
Eligibility as per parental income group per annum	Benefits under the remission of the tuition fee
(a) For GEN, OBC-NC and EWS Categories:	
(i) Less than Rs. 1,00,000/-	Full amount of the tuition fee.
(ii) Between Rs. 1,00,000/- to Rs. 5,00,000/-	2/3 rd of the tuition fee.
Criteria for Interest Subvention on Vidyalaxmi Loan Scheme for B.Tech. (2021, 2022 and 2023 batches only)	
Eligibility as per parental income group per annum	Benefits under the Interest Subvention on Vidyalaxmi Loan Scheme
a) All students whose household income does not exceed Rs 9 lakh shall be eligible for interest free loan under the Vidyalaxmi scheme for the total portion of the tuition fee payable.	Interest free loan under the Vidyalaxmi scheme for the total portion of the tuition fee payable.
b) Criteria for renewal of availing interest subvention:	
(i) Student should secure a minimum CPI of 5.00 at the end of each semester.	
(ii) should not have earned a non-credit grade in any registered course throughout the academic programme.	
If any student fails to fulfill these criteria at the end of any semester, then he / she will be discontinued from benefits of this scheme.	


Mandatory self-attested documents are required while filling online application for the Above:

- (i) Latest parental income certificate (issued by competent authority)
- (ii) Bank passbook (photocopy for account details).

Note:

- Duly signed online generated application form along with all the above relevant documents merged into a **single PDF file** need to be uploaded (**Name of file must be your Roll No. only**). If any student fails to upload the above documents, their application will not be considered.
- The last date for submitting the application is **June 28, 2024 (till 5 PM)**. After the deadline, no application/communication will be considered.
- A Student who receives the above scholarship cannot avail any other scholarship from any Government, Semi-Government, or private sources.
- Decision of the Institute in this regard will be final and binding.
